**Legal basis**

Pursuant to Section 9 Terms of Use for the Hessian Archives of December 20, 2019 (Gazette StAnz. 2020, S. 90), users may generally have copies or reproductions of archival material made in the workshops of the Federal State Archives. This is ruled out only if there is a risk of danger or damage to the archival material. Archival items affecting the interests worthy of protection of persons concerned or of third parties and which are still subject to terms of protection may only be reproduced in exceptional cases. Particular care is then to be taken when publishing and making use of knowledge obtained from such archival material (Section 4 (2) Terms of Use for the Hessian Archives). If the Federal State Archives Hessen does not have the rights of use, or only to a limited extent, the originators or their representatives must be contacted for obtaining the rights of use. The Federal State Archives Hessen shall not be liable for third-party claims arising from the infringement of these copyrights
